### Request under Freedom of Information Act 2000

Thank you for your request for information which we received on 22 February 2021.

I am pleased to confirm the following.

#### Do you provide an accommodation service to employees & new starters?

Yes, we do if they are being employed for MKUH

# Please provide how many rooms/flats you have available to staff broken down by category, i.e. HMO, Short Assured etc

174 HMO single rooms in total & 36 family properties. Assured shorthold Tenancy Agreements if staying longer than 2 months and are substantive staff.

# How much do you charge per night for short-lets, and how much per month for longer lets – for each category of accommodation that you offer.

Standard single room =  $\pounds$ 30.00/night or  $\pounds$ 370.00/month and En-suite room =  $\pounds$ 46.00/night of  $\pounds$ 490.00/month. We don't do short lets in family properties and the rent for a one bedroom flat is either  $\pounds$ 700.00/month or  $\pounds$ 580.00 (2 types), 2 bed house is  $\pounds$ 700.00/month and 3 bed house is  $\pounds$ 786.00/month.

### Do you work in partnership with other organisations to provide an accommodation service? Ie. Housing association, Hotels etc?

We rent from 3 separate Housing Associations.

### If yes - what capacity is this? i.e. how many rooms, flats etc?

All accommodation we have (apart from 1 No. 2 bedroom house which the Trust owns) is rents from Housing Associations.
