We aim to substantive staff in the clinical coding team and do not use bank staff. Currently we have 2 members of staff on a short-term contract to cover a period of time between staff members leaving and new staff members starting.

Our EPR system integrates with Medicode to allow us to clinically code episodes of care on the EPR.

# What are the main challenges the Trust faces in clinical coding (e.g., timeliness, accuracy, staffing shortages)?

Difficulty in recruiting trained staff.
