Thank you for your request for information which we received on 28 May 2021.

I am pleased to confirm the following.

- 1. How many staff do you employ? 3799
  - a) How many doctors? 462
  - b) How many nurses? 1080
  - c) How many healthcare assistants? 396
  - d) How many porters? 39
  - e) How many cleaners? 143
  - f) How many physiotherapists? 56
  - g) How many occupational therapists? 20
  - h) How many social workers? 0
  - i) How many administrative staff? 839

**Other –** 764

Please note that **administrative staff** includes all of the staff group **Administrative and Clerical**, which include all the senior management team.

2. How many staff are on site during a typical 12hr day?

Approximately 2960

- 3. How many working computers do you have in clinical areas?
- 4. How many parking spaces do you have specifically for staff?
  - a. How much do you charge for staff parking? Free of Charge
  - b. How long is the average application period for a staff parking permit? 48 Hrs
  - c. Do you have secure bike storage for staff? Yes
  - d. How many bikes can be securely stored on site at any one time? 82

- 10. Do staff have access to on site showering facilities 24 hours a day? Yes
- 11. Are rest facilities available to staff if too tired to drive home following a night shift? Yes
- **12. How many staffrooms or 'mess' facilities are there on site?** Approximately 55

## 13. What welfare and wellbeing services are available to staff?

All staff have access to the Occupational Health Service. There is a range of health and wellbeing activities, initiatives, and support for all staff – these may change over time. There is a Staff Health and Wellbeing Strategy which guides this.

## 14. Is psychological support routinely offered to staff?

Yes, there is free access to a full Employee Assistance Programme, including counselling and confidential support for all staff

Staff can access coaching. Additional psychological support on site is being developed to support staff at this stage of the pandemic

## 15. Does the trust organise Balint groups or Shwartz rounds for all staff?

Yes, Schwartz rounds are organised for staff
