Thank you for your request for information which we received on Monday 3rd June 2024. I am pleased to confirm the following.

1. Please confirm has your Trust adopted the Just Learning Culture in handling of concerns following receipt of Dido Harding's letter that was sent to all Chairs and Chief Executives of NHS Trusts and NHS Foundation Trusts dated 23 May 2019.

This is currently being implemented.

2. Does your MHPS Procedure set out an informal process to deal with concerns pertaining to conduct/ capability of medical and dental staff, if so please provide details.

Yes, the Trust's MHPS Policy and Procedure does contain an informal process. For allegations of misconduct, the informal part of the Trust's Disciplinary Policy and Procedure would apply. For allegations of performance and capability, supportive action would be put into place.

3. Please provide details of what training and support is provided by your Trust to Case Investigators and Case Managers when dealing with MHPS cases.

We utilise internal training for all roles in the process. Coaching and advice is given to all roles by the Employee Relations Team.

4. Please can you confirm if your Trust has a Decision-Making Group and if so please can you confirm who sits on this group/how this is constituted and its remit?

A decision making group for disciplinary cases does not currently exist however, the Trust is currently in the process of implementing such a group for all disciplinary cases, not just MHPS. We would ensure medical & dental leadership representation on any panels where doctor's conduct cases are reviewed.
