I am pleased to confirm the following.

- How many patients have you treated for suspected and/or diagnosed spider bites in the last five years?

Included are all inpatients discharged from MKUH between the 01 January 2014 and the 31st December 2018 and any of the following ICD10 Diagnosis Codes were coded to the inpatient spell:

X21- Contact with venomous spider

W57- Bitten or stung by nonvenomous insect and other nonvenomous arthropod (includes nonvenomous spider bite)

- Can I please have a yearly breakdown on those figures for 2014, 2015, 2016, 2017, and 2018.

- Can I please request a brief description of the treatment carried out, date of treatment, age and gender of the patient.
