## How much FTE equivalent staff time each network is entitled to. For example, a staff network may have a chair who's entitled to spend 10% of their working hours devoted to the network (please express annually for the last three financial years)

Network Chairs (incl. Deputy Chairs) are entitled to half a day per week (3 <sup>3</sup>/<sub>4</sub> hours per week based on 1.0 WTE contract of employment) of protected time for network duties. Network members are entitled to half a day every two weeks (3 <sup>3</sup>/<sub>4</sub> hours over 2 weeks based on a 1.0 WTE contract of employment).
