The Trust delivered financial performance in-line with plan for 2021/22, continuing a track record of Control Total delivery in recent years. Although the Trust reported a deficit financial position, this was in agreement with local Integrated Care System partners and NHS England and achieved an aggregate system balance.

The Board do not consider that this indicates non-compliance with condition G6 on the basis that the Trust took all such precautions as were necessary to comply with the conditions of the licence, and the Trust's financial performance was in line with that agreed with NHS England.

In respect of CoS7, the Trust has prepared its accounts on a going concern basis and has not identified any material uncertainties in respect of its ability to continue as a going concern. The Trust Board is confident that it will have the necessary financial resources over the next 12 months.
