

Request under Freedom of Information Act 2000

Thank you for your request for information which we received on 23 August 2022.

I am pleased to confirm the following.

Q1. How many patients has your trust treated (for any disease) in the last 6 months (or the latest 6 months data you have available) with the treatments listed below:

- Revolade (eltrombopag) 8 patients
- Nplate (romiplostim) 17 patients
- Doptelet (avatrombopag) 0 patients
- Tavlesse (fostamatinib) 0 patients

Q2. In the last 6 months (or the latest 6 months data you have available), how many patients has your trust treated for immune thrombocytopenia (ITP)?

Please see attached document.

Q3. Of the patients treated for immune thrombocytopenia (ITP) in the last 6 months (or the latest 6 months data you have available), how many were treated with:

- Rituximab 3 patients
- mycophenolate mofetil 1 patient
- surgery (splenectomy)

Q4. Does your trust participate in any ongoing clinical trials for immune thrombocytopenia (ITP)? If so, can you please provide the name of each trial along with the number of patients taking part?

Currently, we have no ongoing **clinical trials** for ITP as such, no patients are receiving treatment as part of clinical research.

We have one ongoing **observational registry study** titled ITP - UK Childhood ITP Registry IRAS 14145 for which we enrolled 13 patients since 2016. 3 in a last 6 months.

We also had another **observational registry study** titled United Kingdom Adult Idiopathic Thrombocytopenic Purpura(ITP) Registry IRAS 92703 for which we enrolled 44 since 2007. 0 in the last 6 months as this closed years ago and is now ready for archiving.
