All new or updated Trust guidelines go through a consultation with relevant consultation with appropriate clinical stakeholders and/or governance forums before validation at the Trust Documentation Group and final approval (where trust wide or corporate) at the Trust Executive Committee.

Most guidelines have a 3 yearly review process unless there are updates required in the interim due to new best practice/national guidance or local changes in processes/pathways. Reminders are sent to authors in advance of review dates as a prompt and escalation reports on breached guidelines are shared within divisional and corporate governance meetings, with requests to urgently review and confirm that currently valid with appropriate information content.
