Thank you for your request for information which we received on Wednesday 12 February 2025. I am pleased to confirm the following.

## Q1. Please provide the total number of patients treated in the last 6 months for:

- Polycythaemia Vera (ICD10 code D45)
- Myelofibrosis (ICD10 code D47.4)
- Myelofibrosis (ICD10 code D47.4) patients aged 65 and older

Q2. How many patients were treated in the past 6 months (for any disease) with:

- **Ruxolitinib** 9 patients
- Fedratinib 0 patients
- **Momelotinib** 2 patients

Q3. How many patients were treated with Ruxolitinib in the past 6 months for the following diseases?

- Myelofibrosis (ICD10 code D47.4) 3 patients
- Polycythaemia Vera (ICD10 code D45) 2 patients
- Other/Unknown 4 patients

Q4. How many myelofibrosis (ICD10 code D47.4) patients has your trust diagnosed in the past 3 years?

- Of these patients, how many were treated in the past 6 months with Hydroxycarbamide? 2 patients
- Of these patients, how many were treated in the past 6 months with Interferon therapy? 3 patients
- Of these patients, how many have received no active treatment in the past 6 months? 17 patients

Q5. Does your trust participate in any clinical trials for the treatment of myelofibrosis? If so, can you please provide the name of each trial along with the number of patients taking part.
